This Amendment No. 6 ("Amendment No. 6") amends and supplements the statement on Schedule 13D initially filed on September 22, 2014, as amended on February 17, 2015, as further amended on May 27, 2015, as further amended on October 16, 2015, as further amended on December 17, 2015 and as further amended on February 3, 2017 (the "Original Schedule 13D") on behalf of SGR Sagittarius Holding AG, AGUTH Holding GmbH and Dr. h.c. Klaus Tschira relating to the beneficial ownership of common shares, par value €0.01 per share (the "Common Shares") of Affimed N.V. (formerly Affimed Therapeutics B.V.), a Dutch public company with limited liability (*naamloze vennootschap*) (the "Issuer"). Harald Tschira and Udo Tschira are the heirs to Dr. h.c. Klaus Tschira and are filing this Amendment No. 6 together with SGR Sagittarius Holding AG and AGUTH Holding GmbH (collectively, "the Reporting Persons"). Except as set forth below, this Amendment No. 6 does not supplement, restate or amend any of the other information disclosed in the Original Schedule 13D. Capitalized terms not defined in this Amendment No. 6 have the meanings ascribed to them in the Original Schedule 13D.
